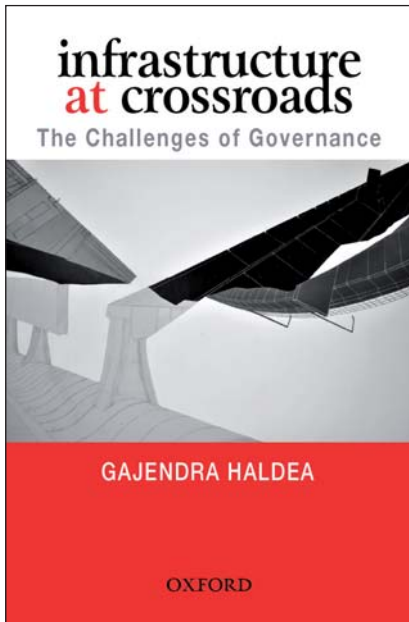

About the Book

This book is a rare insider view of infrastructure sector reforms—where India is, where it should be, and what is stopping it from getting there. It offers a nuanced portrayal of the processes involved at different stages, from conception to implementation, of diverse infrastructure projects—roads, railways, ports, airports, telecom, and power. From policy cobwebs to manoeuvring and rent-seeking, it tells all. It also brings out the half-full glass that offers lessons for the future.

The author recounts his experience of structuring and negotiating recent mega infrastructure projects and of drafting laws, documents, and policies that laid the foundation for private participation in infrastructure. In the process, he critiques the corruption, vested interests, and crony capitalism in the infrastructure sector, and argues that current bottlenecks can only be removed through good governance and reforms in the sector.

Weaving together the political, institutional, and economic, this volume illustrates the complexities involved in the provision of infrastructure and outlines strategies for future development.

Gajendra Haldea is currently serving as Adviser to Deputy Chairman, Planning Commission, Government of India. He has a long standing in public policy, especially infrastructure. On the request of the Power Ministry, he authored the Electricity Bill that was enacted by the Parliament in 2003. He is currently writing the Regulatory Reform Bill and the Public Procurement Bill. He has also authored twelve model concession agreements for public-private partnerships in different sectors, which have been published for use by different authorities. These initiatives have facilitated much of the private investment in India's infrastructure.
